Preamble

It has been observed that Prospective Entrepreneurs of SC and ST category need basic support in handholding and getting leverage to start an enterprise. Therefore, the State Government had introduced Special Package / Scheme namely: "Bharat Ratna Dr. Baba Saheb Ambedkar Udyog Uday Yojna" vide its Resolution dated 24/10/2017 Read at (1).

Provisions under para 10 of the said GR relating to Scheme with Enhanced Assistance to Micro and Small Enterprises (MSEs) for Plot and Shed developed by GIDC, is that GIDC will allot the plot to SC/ST entrepreneur in the estate approved under State Government scheme vide resolution dated 06/12/2018 read at (2) of scheme-1 Scheme for Assistance to GIDC for the development of MSEs Industrial Estate, will be eligible for assistance up to 70% of the allotment price of GIDC.

SC/ST MSME beneficiaries were allotted plots at GIDC Estate, Khirsara, Rajkot during the course of this scheme between dt. 01/04/2017 to dt. 06/08/2020. However GIDC had not sent request to MSME Commissionerate for covering these enterprises under the said scheme. Hence the issue was put up in SLIC-3 read at (3) and Industries Commissionerate proposed the matter to the Industries and Mines Department as read at (4) which were under consideration of Government to cover these enterprises under this scheme as a "Special Case".

Resolution

After careful consideration, the State Government has decided to give the benefit of "Bharat Ratna Dr. Baba Saheb Ambedkar Udyog Uday Yojna" to the SC/ST Entrepreneurs of MSME who were allotted Plots at GIDC, Khirsara, Rajkot between dt. 01/04/2017 to dt. 06/08/2020 as a "Special Case" by extending the time limit under following conditions.

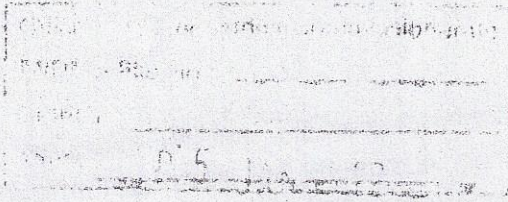

### Conditions

- (1) The extension of time limit specified under this scheme shall be applicable only to those beneficiaries of SC/ST Entrepreneurs of MSME who were allotted the plots between dt. 01/04/2017 to dt. 06/08/2020, at GIDC, Khirsara, Rajkot.
- (2) It shall be confirmed that the beneficiary has not received any Government benefit before making the payment to the enterprise under this liberation.
- (3) Necessary budget provision has to be made for this.
- (4) Payment of incentives must be made to all the eligible enterprises within six months from the date of this issuance.

This issues with the concurrence of Finance Department vide note dated 23/11/2021 on this department file of even number.
