- 3) Offers submitted without digitally signed will not be accepted.
- 4) Offers i.e. Pre-qualification document with Technical Bid & Price Bid in physical form will not be accepted in any case.
- 5) It is Bidder's responsibility to verify Online Corrigendum / Amendments until last submission date and time as well as before Final Submission of Bid. Required documents for pre Pre-qualification document received later than the time specified will not be accepted in any case and the bid of that bidder shall be considered non-responsive

6) (C) Submission of Tender Fees, EMD

- 2) EMD in the form of Account Payee Demand Draft / F.D.R. drawn on any Scheduled / Nationalized Bank in favor of **"GIDC" payable at Gandhinagar.** Demand Draft for E.M.D. & Tender Fee shall be submitted in Electronic Format only through Online (by scanning) while uploading the Bid. This submission shall mean that E.M.D. & Tender Fee are received. Accordingly, offer of those shall be opened whose E.M.D. & Tender Fee is received electronically as well as received in physical form. **For the purpose of realization of D.D. as stated above under para (C- 1 & C - 2).
