- 6) Required documents for pre Pre-qualification document received later than the time specified will not be accepted in any case and the bid of that bidder shall be considered non-responsive.

EMD in the form of Bank Guarantee of the Scheduled Bank or Nationalized Bank also acceptable as per the manner set out in the prevailing Form B1 & Form B2.

This submission shall mean that E.M.D. & Tender Fee are received. However, bidder shall send the D.D. in original along with other documents by RPAD/Speed Post/ Hand delivery within date & time specified.**
