- 2) Bidder shall submit their offer i.e. Pre-qualification document with Technical Bid & Price Bid in Electronic format on above mentioned website & up to Date shown above after digitally signing the same.
- 3) **For the purpose of verification**, the original documents for Pre-qualification submitted in electronic format for Sr. No. 1 should be submitted in physical form as under: -

- 6) It is Bidder's responsibility to verify Online Corrigendum / Amendments until last submission date and time as well as before Final Submission of Bid.
