Preamble-

Government of Gujarat has introduced Scheme for Assistance to Micro, Small and Medium Enterprise (MSME) read at (1) and BharatRatna Dr. Baba Saheb Ambedkar Udyog Uday Yojana for SC/ST Entrepreneurs of MSME read at (2) under Gujarat Industrial Policy - 2015. Amendments/Clarifications have been issued regarding the implementation of the scheme vide Government Resolution read at (3) and (4) above. The limits for submission of the application for registration under the scheme have been clarified vide G.R. read at (1) and (2) above. Due to World Wide COVID-19 Pandemic in Country, lockdown was imposed in March 2020. Due to this situation, representations for more relaxation in time limit fixed by the resolution read at (5) and (6) above to submit application have been received from various Industrial Associations.


Resolution-

After consideration, Government is pleased to grant further extension in time limit for application under Assistance of Capital Investment Subsidy and Assistance for Interest Subsidy under Scheme for Assistance to Micro, Small and Medium Enterprise (MSME) and BharatRatna Dr. Baba Saheb Ambedkar Udyog Uday Yojana for SC/ST Entrepreneurs of MSME, as under :

1. MSME Unit eligible under the scheme, but could not apply from 22nd March,2020 to 31st July,2020 due to Covid-19 Pandemic, shall have to apply within 90 days from the date of issuance of this resolution.
2. If any application is rejected/partially approved on the ground that the application is not submitted within the time limit(Where maximum permissible time limit for application falls between 22nd March,2020 to 31st July,2020) due to Covid-19 Pandemic, in that case such applications will have to be reopened/relooked and approval should be given, if deemed fit.
3. The time limit extension of Point No. 1 and 2, for the application applies only to Assistance of Capital Investment Subsidy and Assistance for Interest Subsidy of the above mentioned G.R.s.
4. Other terms and conditions of the schemes will remain the same.
